Below is a repair tip from Alain Francois. Alain has generously agreed to submit tips periodically  
Thank You Alain !!!

### **Alain's Repair Tip:**

**This is for a Maxitherm or Mastertemp.**

If your ignition cycle completes itself ( demand for heat, blower on, all switches good, 3+ Amps on the igniter, no more than than .7 amps on the blower wires, you hear the click from the gas valve opening andyou smell gas) but the heater does not fire, you have a carburation problem.

First look for the obvious, do a manometer gas pressure reading, should be around 8"wc static, minimum of 4"wc with heater fired for natural gas, 14" wc to11" wc static, and at least 5" wc on for propane.

If you have proper pressure, check gas orifice, and end cap on the blower intake and make sure that they are correct. If heater is indoors, disconnect vent pipe, and see if heater fires with vent disconnected.
